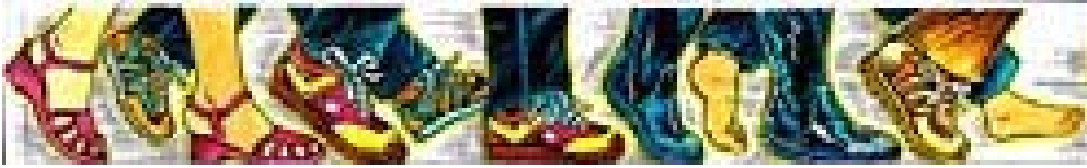

Dear Senator Steinberg,

PLEASE protect Prop 63 and Prop 10. Do not allow the Gov. and the Republicans to raid these programs. If these programs' revenue is transferred into the General Fund, they will have to compete with schools, prisons, all other health and social services, etc. We will see the end of Mental Health and children's health services except for those with MediCAL in the state. This will result in more police having to jail the mentally ill, more psyche wards and ERs unable to meet psychiatric emergencies, more sick children and a system straining because of the need to use higher cost services. PLEASE don't allow this to happen. We need mental health and children's health services. The millionaires and the tobacco industry don't like it but the people do. They voted overwhelmingly last May to defeat Props 1D and 1E. This new proposal is more of the same on steroids!

Every ten years after the census, California goes through the process of redistricting – redrawing the political districts from which representatives of the State Senate, Assembly, and Board of Equalization are elected. Drawing district lines was historically a duty of California lawmakers. Now, citizens like YOU have the power to draw these lines by serving on a new 14-member commission – the Citizens Redistricting Commission!
