# ***PROXY REQUIREMENTS***

- A. Members of This Committee may be represented at any meeting of This Committee by proxy. A member may give his/her proxy to a registered member of the California Democratic Party, of the same sex whenever possible, who is not already a member of This Committee subject to the following limitations:
  - (1) A member elected by a County Central Committee may only give his/her proxy to a member, as defined by its by-laws, of the same County Central Committee.
  - (2) A member elected by an Assembly District Election Meeting may only give his/her proxy to a registered Democrat resident in the same Assembly District.
  - (3) A proxyholder shall vote only in the district in which the person for whom he/she is a proxy, resides.
- B. Proxies shall be signed by the member under penalty of perjury and shall be in the form prescribed by the Secretary of This Committee.
- C. No proxy shall be recognized unless filed with This Committee prior to the close of registration for a meeting of This Committee.
- D. Revocation or change of proxies shall be recognized by the Credentials Committee only upon a request made by the member in person before that committee.
- E. No person may hold more than one proxy. Voting by proxy shall not be permitted with respect to standing or special committees of This Committee.
- F. Proxy forms must be filed at the State Party Office, 1401 - 21st Street, Suite 200, Sacramento, CA 95811-5221, by 5PM Wednesday, April 22, 2009 or filed in person at the Convention Proxy Registration Desk at the Sacramento Convention Center. Please note that the Proxy desk closes on Sunday, April 26, 2009 at 9:30AM.

# STATE PARTY REGIONS

**State Party Regions are based on Assembly Districts and are adopted after each official Legislative Redistricting. The following list roughly describes the current State Party Regions. Regional Directors elected at this Convention will be elected under this plan.**

**Region 1: Assembly Districts 2, 3, 4.** Northern, inland, rural California, from Oregon down to the edges of Sonoma, Sacramento and the Gold Country.

**Region 2: Assembly Districts 1, 6, 7.** North Coast from Del Norte through Marin and Sonoma.

**Region 3: Assembly Districts 5, 8, 9, 15.** Sacramento, Yolo, Solano and east Contra Costa/Alameda.

**Region 4: Assembly Districts 12, 13, 19.** San Francisco and most of the peninsula.

**Region 5: Assembly Districts 21, 22, 23, 24.** Northern California's "South Bay."

**Region 6: Assembly Districts 11, 14, 16, 18, 20.** East Bay.

**Region 7: Assembly Districts 10, 17, 25, 26.** Upper San Joaquin Valley and lower Gold Country.

**Region 8: Assembly Districts 29, 30, 31, 32.** Lower Central Valley from Fresno through Bakersfield.

**Region 9: Assembly Districts 27, 28.** Monterey, Santa Cruz and San Benito counties.

**Region 10: Assembly Districts 33, 35, 37, 41.** San Luis Obispo, Santa Barbara, Ventura and a part of NW corner of Los Angeles County.

**Region 11: Assembly Districts 34, 36, 59.** Inyo, Mono, Tulare down to most of San Bernardino and NE part of LA County.

**Region 12: Assembly Districts 43, 44, 45, 49.** Burbank and Pasadena, downtown LA through El Monte.

**Region 13: Assembly Districts 38, 39, 40, 42.** High Desert, Santa Clarita, San Fernando Valley, Beverly Hills and West Hollywood.

**Region 14: Assembly Districts 47, 48, 51, 52.** Culver City, Crenshaw, Inglewood, parts of LA City.

**Region 15: Assembly Districts 46, 56, 57, 58.** East LA/Southeast LA

**Region 16: Assembly Districts 60, 61, 62, 63, 72.** North Orange, east San Gabriel Valley into San Bernardino.

**Region 17: Assembly Districts 50, 53, 54, 55.** Beach Cities/South Bay, Carson, Long Beach.

**Region 18: Assembly Districts 67, 68, 69, 70, 71.** Most of Orange County.

**Region 19: Assembly Districts 64, 65, 66, 80.** Primarily Riverside and Imperial.

**Region 20: Assembly Districts 73, 74, 75.** South Orange/Northern San Diego Counties.

**Region 21: Assembly Districts 76, 77, 78, 79.** San Diego metro area and east county.

# 2009 CONVENTION RULES

## Rules for the 2009 California Democratic Party Convention

1. The primary purpose of this biennial Convention is to organize the newly-elected constituted Democratic State Central Committee (This Committee) and elect Statewide Officers and Regional Directors. Matters not heard at the Convention will be received by the Secretary and held over to the next meeting of the Executive Board.
2. The Chair of This Committee shall be the Chair of the Convention and the Secretary of This Committee shall be Secretary of the Convention.
3. Delegates to the Convention shall be the members of the Democratic State Central Committee or their proxies as specified in the by-laws, whose appointment/election has been transmitted to the State Party no later than February 7, 2009.
4. Seating of the delegates shall be by the Assembly District within Region.
5. No one will be admitted to the Convention floor who is not a delegate, or proxyholder, except by special authorization of the State Chair.
6. Registration will close as specified by the agenda.
7. The Credentials Committee shall issue its final report and place the official voting list of delegates in the hands of the Convention Secretary subsequent to the close of registration and prior to the agendized credentials report.
8. Election of Statewide Officers and Regional Directors.
  - a. All Statewide Officers shall be elected by the entire membership of This Committee. The election of all offices shall take place on Saturday, April 25, 2009. If a Statewide office requires a run-off, that run-off will be held early Sunday, April 26, 2009. Regional Caucuses comprised of all members of This Committee resident in the respective regions shall take place for the purpose of electing their respective Regional Directors. A candidate for any office shall file a notice of intent-to-run for that office with the Secretary of the Party no later than 5:00 PM, April 8, 2009, being the day which is sixteen (16) days prior to the commencement of credentialing for the Convention. Should the incumbent officeholder fail to file the notice of intent-to-run by that date, then the filing deadline shall be extended to 5:00 PM, April 15, 2009, being the date which is nine (9) days prior to the opening of credentialing for the office. No withdrawals shall be allowed after that date. Note: As there is no 2005-2009 "Male Vice Chair", the filing deadline for this race will NOT be extended.
  - b. Following the close of nomination for officers, no additional nominations shall be permitted, except for an office for which no person has been nominated prior to the close of nominations or for which all persons nominated have withdrawn.
  - c. No vote for any person shall be counted unless the person has been duly nominated for, and has accepted that nomination for the office for which such vote is cast.
  - d. In the event only one person is nominated for any office and such person accepts the nomination, the Secretary of the meeting shall be directed to cast a unanimous ballot for such candidate at the time of the election.
  - e. In the event no candidate receives a majority on the 1st ballot, a run-off election (2nd ballot) shall be held between the two persons receiving the largest number of votes actually cast for all candidates who have been duly nominated for and accepted the nomination for the office involved.
  - f. All voting for officers shall be by DNC mandated open ballot process except when there is only one candidate.



# 2009 CONVENTION RULES - CONT.

9. The Resolutions adopted by the members of This Committee and the Executive Board of the California Democratic Party are expressions of philosophical beliefs and principles that the Party wishes to declare. Any resolution involving a local issue will be referred to the appropriate local Democratic Party entity.

## RESOLUTION PROCEDURES

- a. Form
- (1) All resolutions must be typed.
  - (2) Inducement (e.g., Whereas) clauses shall be limited to three (3) or less, and resolve clauses shall be limited to two (2) or less.
  - (3) Resolutions must be no longer than one (1) 8-1/2" x 11" typewritten page.
  - (4) All resolutions must be adopted by a County Central Committee, or a Chartered Democratic Club or sponsored by twenty-five (25) members of This Committee, or a majority of the members of This Committee who meet at a Regional Meeting.
- b. Timely Resolutions
- (1) Resolutions must be received by the State Chair of the Party, thirty (30) calendar days prior to a meeting of This Committee, except as provided in subsection (c) below.
  - (2) Copies of resolutions submitted according to the above procedure shall be mailed by the State Chair of the Party to all members of the Resolutions Committee prior to a meeting of This Committee.
- c. Resolutions Committee will present prioritized resolutions in the committee report to the convention body.
- d. Late/Floor Resolutions
- (1) Twenty-five (25) copies of each resolution must be provided to the Resolutions Committee by the sponsor(s) of the resolution.
  - (2) All resolutions to be considered at a meeting of This Committee must be presented for consideration at the Resolutions Committee meeting preceding the general session. In order to be considered at the general session, a late resolution must have the unanimous consent of the Resolutions Committee to be considered and all resolutions must be approved by the Resolutions Committee. Any resolution heard by the Resolutions Committee, failing to obtain approval, may be brought to the floor of a meeting of This Committee with the signatures of three hundred (300) members of This Committee on forms approved by the Resolutions Committee.
  - (3) All resolutions to be presented from the floor shall be submitted to the Secretary of the Convention for signature verification by 5:00P.M. on the day before the resolution is presented.
  - (4) The sponsor of a resolution presented from the floor shall be responsible for providing the Secretary of the Convention with sufficient copies of their resolution for each member of This Committee.
- e. Resolutions pending at the close of a Convention of This Committee shall be referred to the Executive Board of This Committee. All such resolutions shall first be presented to the Resolutions Committee for recommendation to the Executive Board. The Resolutions Committee shall recommend: adoption, adoption with amendment, or rejection. Such resolutions shall be presented to the Executive Board for consideration in its original form unless the sponsor agrees to the amendment(s) recommended by the Resolutions Committee.
10. Requests to hang signs, banners and placards must be submitted before the Convention to the Convention Coordinator. A small fee may be charged per sign.
11. In all cases at this Convention, proxies vote in districts where the appointing member resides as required by This Committee's By-Laws.

# **2009 REFUND/NSF CHECK POLICY**

## **REGISTRATION FEES:**

If after submitting registration fees you cannot attend the convention, you may request a refund of fees. All requests must be submitted in writing and must be received by March 27, 2009 in the Sacramento office: California Democratic Party, Attn: Refund Department, 1401 - 21st Street, Suite 200, Sacramento, CA 95811-5221 or fax: 916-442-5991.

A refund of the registration fee minus an administrative fee of \$20.00 **per person** will be given only if your refund request is received on or before March 27th.

**THERE WILL BE ABSOLUTELY NO REFUNDS OF REGISTRATION FEES AFTER MARCH 27, 2009.**

## **MEAL COSTS:**

To cancel your meal(s) you must submit a written request for a refund of meal costs to the Sacramento office: California Democratic Party, Attn: Refund Department, 1401 21st Street, Suite 200, Sacramento, CA 95811-5221 or fax: 916-442-5991.

A refund of the price of the meal(s) minus an administrative fee of \$20.00 per refund will be given only if you request a refund on or before April 3rd. **THERE WILL BE ABSOLUTELY NO REFUNDS OF MEAL COSTS AFTER APRIL 3, 2009.**

## **RETURNED CHECK POLICY:**

Individuals/organizations will be held responsible for any returned checks. All checks returned for Non-Sufficient Funds (NSF), account closure or other reasons will be subject to a \$25 returned check charge. Replacement funds, including the returned check charge, will be required in the form of a certified check, money order or traveler's check in order to register at the convention (**cash payments in excess of \$99 are not permissible under FEC/FPPC regulations**).

This policy also applies to any current or past debts owed by delegates to the California Democratic Party.

California law imposes no limit on contributions used for purposes other than supporting state candidates. Federal law requires political committees to use our best efforts to report the name, mailing address, occupation and employer for each individual whose contributions exceed \$200 in a calendar year.
