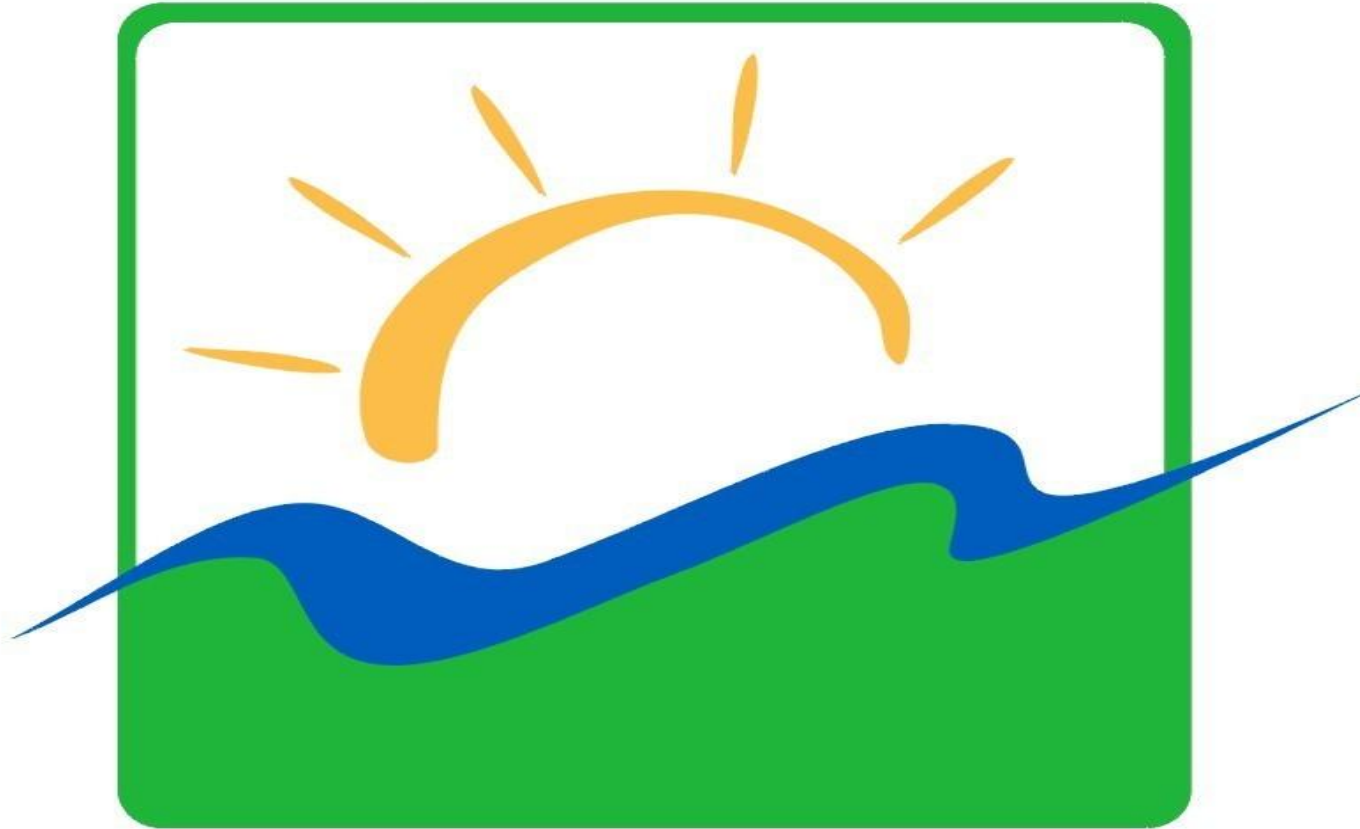

- The Meeting was Adjourned



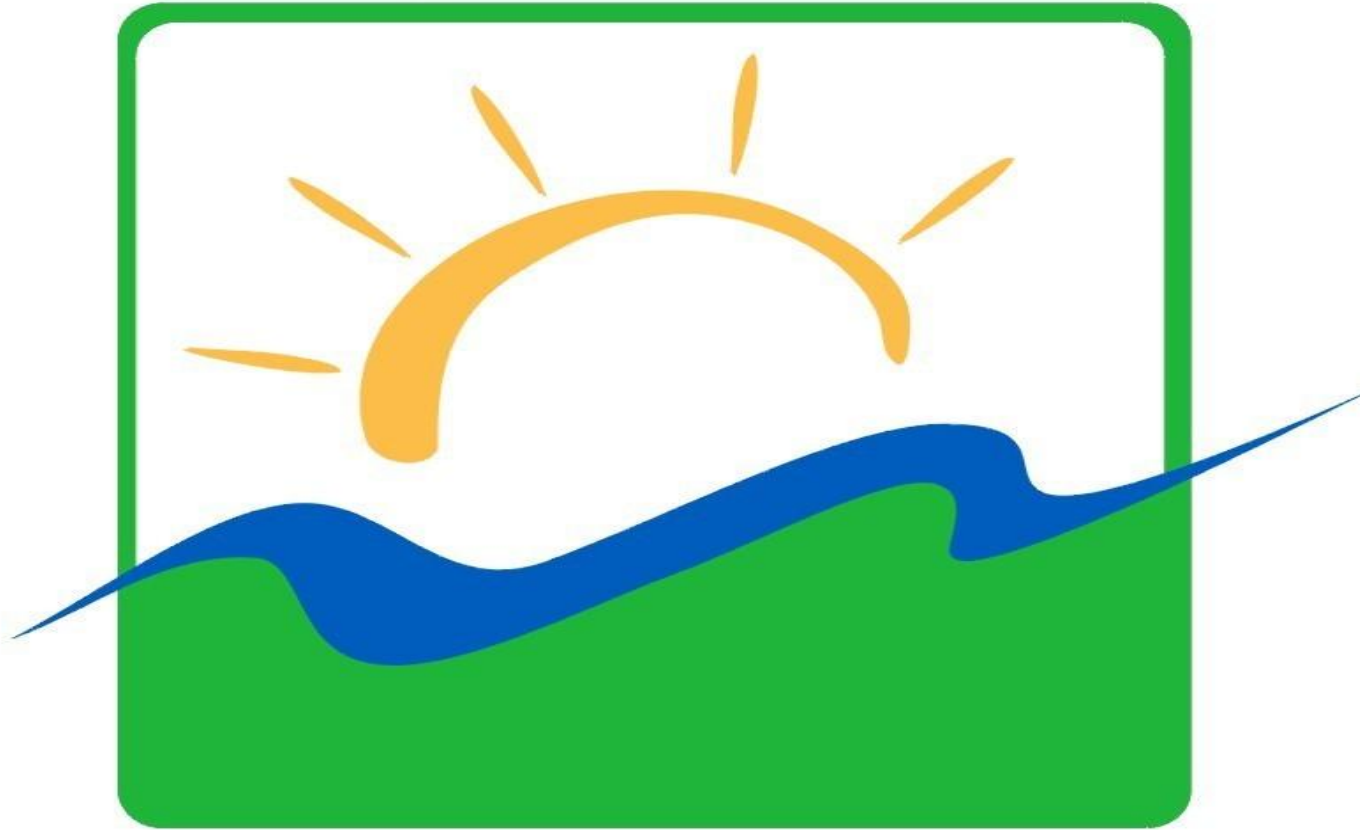
