Corporate contributions cannot be accepted. Contributions are not tax deductible. Federal law requires political committees to report the name, mailing address, occupation and name of employer of each individual whose contributions aggregate in excess of \$200 in a calendar year.

Individual contributions to Sherman for Congress are limited to \$4,800 per person (\$2400 for Primary 2010, \$2400 for General 2010). Multi-candidate PACs are limited to \$5,000 per candidate, per election. Contributions from the general treasury funds of corporations, labor unions and national banks; federal government contractors, and foreign nationals are strictly prohibited. Federal law requires us to use our best efforts to collect and report the full name, mailing address, occupation and name of employer of any individual whose contributions exceed \$200 in an election cycle.
